

Evicting protestors

Case Study: Parliament Square

When peace protestors spread their makeshift camp across Parliament Square, creating an eyesore, the Greater London Council (GLC) brought in Shergroup to evict them.

Acting on a Writ of Possession obtained from the High Court, 20 of Shergroup's High Court Enforcement Officers worked with the Metropolitan Police to remove the 60 demonstrators and all their belongings from the square.

It was a meticulously planned operation with many challenges, including the need to use our specialist climbing team to remove protestors who had locked themselves onto scaffolding.

Officers worked through the night to escort protestors off the site, and by dawn the site had been cleared, ready for Shergroup Security to erect perimeter fencing and prevent re-entry.

Securing a site

Shergroup Security specialises in protecting commercial, industrial and domestic premises from intruders. We provide security for land and property on high-value and high-risk sites, where the threat from disruption or damage to property is high.
